➤ Special Student Report – SUNY Orange Cross Country Team

Dr. Young honored the Athlete Director, Wayne Smith, for his achievements and commitment. He introduced the 3 fulltime students, student athletes all dedicated to train through COVID which brought them to the Nationals in Georgia this year. Each student shared their college and personal experiences all positive in nature, and have all recommended the SUNY Orange College and experience to their peers. Trustee congratulated them for an outstanding season and thanked them for sharing your time and experiences this evening.

College Reports

- ➤ General Update President Dr. Kristine Young
- Middle States interviews with principals of the college are filling in the gaps of data collection, with the next steps to draft the findings. The progress is well under way with the current and past chairs on the upcoming interview list.
- ➤ There is a scheduled EMT/CRT meeting tomorrow morning to address the changing set of issues for the upcoming spring 2022 semester. We will have to communicate clearly for the College, community and employees.
- ➤ Guided Pathways / SOEX Vice President Gerianne Brusati and Vice President Erika Hackman. Ms. Brusati described the best practices at Community Colleges and the importance of integrating the practices college wide, by creating clear, coherent, guiding students to point of gradation, transfer and careers. SOEx stands for the SUNY Orange experience, helping us frame our priorities; education reform, program mapping, scheduling improvements and reframing our academic advising. Dr. Hackman shared that Guided Pathways is an ongoing effort to keep the program moving forward in a

- positive way, so the efforts will be continuing.
- ➤ Workforce Development President Dr. Kristine Young The companion piece to the SOEx is the workforce development component. There are both credit and non-credit scenarios based on how we are funded in New York. Some creative solutions on the credit side, as an example, is PTech. Some PTech students can graduate from High School and SUNY Orange at the same time. This model may be a model to be mimicked in the future. 22 Faculty have received Career Advising Certificates and are already advising students. One the non-credit side, it's time to flip the script and to be viable in today's environment, we need to look to the industries for the skills they are looking for and design curriculum around their needs. Measurable outcomes will be available in the future.

➤ Governance President – Paul Basinski

> January Governance meetings will begin in person to interact in the physical space. Nothing to report regarding the Enrollment Management Taskforce, it did not meet last month.

Student Trustee – Kira Pedicini

The haunted car event was a success raising \$1,200 for cancer research. Dr. Young presented at the Business Club which was an interesting event with a great deal of insightful questions being asked. We will be voting on the remaining funds in the Student Activity Account with a suggested breakdown as follows; \$25K to be used to keep the activities going, \$15K in gift cards for the Food Pantry and \$25K towards employing a Social Worker to assist students with applying for food stamps and similar programs.

E. College Association - Paul Martland

➤ The food service and the Lab programs numbers are above last year, yet not to the level of 2019, pre COVID. The 2022 plan should be broader range plan to improve the viability of the Association. The Hoffman Street property has received a full price offer, which has been accepted.

> \$100,000 of funding that has been held will be matched and we are looking for utilizing those monies. The audit will be complete before the end of the year.
