What Students Should Know: COVID-19 and Returning to Campus

As we return to campus in Spring 2021, SUNY Orange's first priority is the health and safety of our College community, including its students, faculty and staff. The best way to maintain the safest environment possible throughout 2021 and beyond is for each of us to take steps to minimize the risks, not only for ourselves, but for all members of the SUNY community. This includes:

- wearing face coverings (masks)
- hand washing
- social distancing
- participating in testing and tracing
- completing daily screenings
- being mindful of our surroundings and the impact we have

Any of us alone can spread this disease and cause harm to others. But **all of us together can build a community that is safe and healthy**, where educational success is possible.

Here's what you need to know and do as SUNY and SUNY Orange welcome students back to campus in 2021:

Stay Informed

The College has established a <u>COVID-19 webpage</u>, accessible from an alert message on all pages of the <u>www.sunyorange.edu</u> website. This section lists timely information and resources for employees, students and community members. Links connect you to student FAQs; student resources; protocols for reporting virus symptoms; testing and screening information, and more. Essential messages from the College will also be distributed internally to students via @sunyorange.edu email accounts, as well as in the Student Grapevine. Content from the Student Grapevine newsletter is also available on the College website as well as on your home tab in MySUNYOrange. As appropriate, updated content will also be posted on the College's social media accounts (Facebook, Twitter and Instagram), for widest dissemination

Return to Campus Safely – Testing and Isolation Requirements

For two weeks prior to a return to campus, all students who will be participating in in-person, on-campus activities must be pre-screened daily for travel history, COVID-19 history and COVID-19 symptoms Students who will start on-campus instruction on Jan. 25 must begin daily use of the <u>Campus Clear</u> app as of **Monday, Jan. 11** *(as communicated to in-person students via email on Jan. 8)*. Students who will start on-campus instruction on Feb. 1 must begin daily use of the <u>Campus Clear</u> app as of **Monday, Jan. 18**.

Additionally, students must participate in a seven-day precautionary quarantine prior to their return to campus. Exceptions will be granted for Health Professions students who are essential workers, students who need to work, students who have already had COVID-19 or who have tested negative for COVID-19 as outlined below.

Before arriving for in-person, on-campus academic instruction on Feb. 1, all participating students must:

- Submit an <u>attestation of completion of a precautionary quarantine</u> from the period beginning on Jan. 25 (for those nursing and radiologic technology students resuming in person on Jan. 25, the attestation period begins Jan. 18) OR
- For Health Professions students, <u>provide documentation</u> of "essential worker" status" to be exempt from precautionary quarantine

OR

- If employed outside of the College, <u>request exemption</u> to enable work during the quarantine period. To qualify for the exemption, students will need to document the COVID-19 safety protocols of their employers. When not working, the students will be expected to quarantine from others AND
- Submit a negative COVID test taken Jan. 29 or later for students returning on Feb. 1 (those nursing or radiologic technology students must submit a negative test result taken Jan. 22 or later). <u>Test results can be uploaded here</u>.
 - OR
- Participate in on-campus testing within five days of return to campus (see below) OR
- Submit a positive diagnostic COVID test result from November 2020 or later. <u>Test results can be</u> <u>uploaded here</u>.

Get Screened Daily

All students must use the <u>Campus Clear</u> app every day they come to either SUNY Orange campus, and be prepared to show the green "Good to Go" screenshot if asked to do so by faculty or staff.

Get Tested Regularly

Surveillance pooled testing is required of all students who will regularly be on campus as of January 25/ February 1. Testing begins on Monday, February 1 and continues on a bi-weekly schedule throughout the semester. Students may opt for the most convenient location but **must test every other week while their class is meeting on-campus.**

Testing will be available from 10 a.m. to 6 p.m. as follows:

- Tuesday Middletown Campus: Feb 2, 16, Mar 2, 16, 30, Apr 13 & 27
- Wednesday Middletown campus: Feb 3, 17, Mar 3, 17, 31, Apr 14 & 28
- Thursday Newburgh Campus: Feb 4, 18, Mar 4, 18, Apr 1, 15 & 29

Check the COVID-19 Dashboard

SUNY maintains a comprehensive dashboard of COVID-19 testing and infection rate status across the system and at each campus. SUNY Orange will report daily COVID-related information to the <u>SUNY COVID-19 Tracker</u> in accordance with guidelines set forth by SUNY. The College community, along with external partners and community members, will be directed to the SUNY COVID-19 Tracker for data related to SUNY Orange.

Be Responsible – It's Easy to Do Your Part

Each of us can take small steps to protect ourselves and the campus community. Because COVID-19 is highly contagious, these simple measures apply **both on and off-campus**:

- All students, employees and visitors are required to <u>wear a mask or face covering</u> over nose and mouth at all times when indoors on either campus, including in classrooms, conference rooms and other spaces, even when six-feet social distancing exists. Exceptions to mask wearing include when students are eating meals on campus while seated and social distancing is appropriately enforced, or by themselves. Faculty and staff are likewise exempt when alone in their office or other space.
- Masks must be worn on outdoor campus grounds if social distancing cannot be maintained, but it is recommended to wear masks at all times, even when social distancing can be maintained.
- **Regularly wash your hands** with soap and water for at least 20 seconds and use hand sanitizer where soap and water are not available.
- Stay home when you are sick or have potentially been exposed to COVID-19.

• Practice social distancing at all times to reduce transmission.

If Exposed, Complete Mandatory Quarantine and Isolation

Students who test positive for COVID-19, have been exposed to individuals who tested positive for COVID-19, or are informed by a state or local health department, or medical or campus official that they are "at risk" for having COVID-19 may be required to quarantine or isolate. This may include taking classes remotely, and not accessing campus facilities.

The College will assist the local and state Health Departments with tracing, tracking and reporting of cases, and those notified through the contact tracing process will be asked to:

Self-quarantine at home, in accordance with timelines established by the <u>Orange County Department of Health (OCDOH)</u>, is required for any employee/student who has a confirmed exposure to a positive COVID-19 individual per OCDOH protocols. They will be notified by the OCDOH. For instances where a student or employee resides outside of Orange County, the College will work with the health department in the home jurisdiction of that individual.

The SUNY Orange Wellness Center will be notified by the Orange County DOH of all confirmed student cases that have been on campus during their infectious period per contact tracing investigation. SUNY Orange liaison's designated to maintain communication with the OCDOH as follows:

Follow the Rules or Face Disciplinary Action

When SUNY Orange learns of a violation of the rules associated with COVID-19 safety, students may lose access to campus facilities. Other disciplinary actions may be taken by the Student Conduct and/or Human Resources Offices. Student conduct is governed by the SUNY Orange <u>Student Code of Conduct</u>. Minimum sanctions, as set by the Chancellor for the entire SUNY system, are outlined in the <u>Uniform Sanctioning in Response to COVID-19</u> <u>Student Violations</u>. Consistent with SUNY policy, students who are partially or completely removed from the institution due to a violation are not eligible for refunds.

Take Care of Yourself – Physically and Mentally

The Wellness Center is open to all students, free of charge. Its programs are designed to promote health education and wellness for our campus community. The College's mental health and nursing services are also available to all students.

The Wellness Center will follow and monitor the guidance of the American College Health Association, CDC, the New York State Department of Health, SUNY, and the local health department. The Wellness Center will provide multiple means of educating the College community on how to stay safe and on infection control procedures. Mental health efforts will be aligned with ACHA COVID-19 reopening guidelines. Mental health resources will be shifted to tele-mental health and wellness programming.

Students and employees are also encouraged to utilize community-based mental health resources, including: <u>ReachOut SUNY</u>, <u>Thriving Campus</u> and <u>Middle Earth</u> (from the University at Albany). Understand What's Being Offered On-Campus and Online

For the Spring 2021 semester, SUNY Orange will offer instruction in the following course formats:

- **Remote Synchronous (RS):** Remote learning with synchronous (real time) instruction at the designated days/times indicated on the schedule. Please note, to participate in the class, students will need to use a device with a microphone and camera.
- Virtual Campus (V): Distance learning within a flexible time frame (0% real time instruction required; asynchronous). Please note, to participate in the class, students may need to use a device with a microphone and camera.
- Blended (BL): Remote learning that integrates some synchronous instruction at the designated days/times indicated on the schedule and some asynchronous instruction. Please note, to participate in the class, students will need to use a device with a microphone and camera.
- Middletown Campus (M): Some in-person, on-campus instruction is required on the Middletown campus.
- Newburgh Campus (N): Some in-person, on-campus instruction is required on the Newburgh campus.

Barring unforeseen circumstances, SUNY Orange plans to offer 15 percent of courses in a face-to-face (M or N) format. The remaining 85% of courses will be offered in remote formats (RS, V, and BL).

- Request Accommodations for Disabilities: Students who wish to disclose covered disabilities and receive reasonable accommodations for their disabilities should contact the Office of Accessibility Services at accessibilityservices@sunyorange.edu or (845) 341-4642. The steps to requesting Accessibility Services are; applying for Services Online Application for Accessibility Services, submitting appropriate documentation of a disability and scheduling a remote intake appointment with OAS staff. All of the steps must be completed before students can receive any academic accommodations if they are deemed eligible. Documentation and accommodation requests may be submitted at any time of the semester.

If We Have to PAUSE, Follow These Rules

In the event of a PAUSE, all in-person, on-campus instruction will move to remote formats for the duration of the PAUSE. Student support services will continue to be available in remote formats.

If We Have to Pivot to Remote Instruction, Follow This Plan

All faculty teaching in-person, on-campus courses will communicate to students their plans for pivoting to remote instruction (should the need arise), in their course syllabus.

Changes and Updates: The ongoing COVID-19 pandemic creates a fluid situation that may require unexpected changes in our response. Updates to scientific knowledge, public health guidance, or laws and regulations may mean SUNY and SUNY Orange have to make changes to our standards and rules, including those indicated above. SUNY and SUNY Orange will try to minimize these changes and their impact. We will keep you informed of new developments.
