# **COURSE DESCRIPTION**

The student gains experience in early childhood through supervised participation in local facilities where, over the course of a year, they take increasing responsibility in the various roles of early childhood professionals. In a weekly seminar/lecture, students discuss their field experiences, and learn to develop early child education curricula including these areas: Art and Creative Experiences, Music, Movement, Physical Activities, Creative Play, Language Arts, Beyond Books, Discipline and Classroom Management\*. A grade of C is required to continue and graduate in the A.A.S. program

Prerequisite: EDU 101, EDU 102, EDU 111 and permission of instructor/coordinator\*\*

Corequisite: EDU 201

\*\* Students who took EDU 103 MUST meet with their advisor. Possible waivers MAY be given for certain EDU courses.

NOTE: EDU 203 and EDU 204 require documentation of a satisfactory physical examination, negative tuberculin test, chest x-ray as stipulated by state regulations. Fingerprinting and State Clearance Registry forms required.

#### **COURSE GRADING SYSTEM**

**50** % of Final Grade will be based on:

• Evaluation of the student's competency as demonstrated in the field placement site by observation and assessment of the cooperating teacher and college supervisor (See attached Monthly Field Evaluation)

50% of Final Grade will be based on:

• Quality of written reflective journal entries 5%, written lesson plans 20%, Resume 5%, Philosophy Statement 5%, Portfolio 10% and active participation in weekly seminars on campus 5%.

Instructor withdrawals are done only in extraordinary circumstances. Dropping a class without going through the official procedures will result in a failing grade.

Successful completion of this course can only occur with at least a grade of C. A C- or lower would mean that you would have to repeat this class the following fall semester, thereby postponing graduation from this program, by a full year.

# **GENERAL COURSE INFORMATION**

Seminar attendance is essential, and one unexcused absence may result in an Instructor withdrawal.
